Assignment 2. Title: "My Mother Through My Eyes: A Personal Documentary" (With reference to the poem My Mother at Sixty-Six by Kamala Das)

Assignment Task:

✓ Create a short documentary (3–5 minutes) titled:

"My Mother Through My Eyes" or "Spending Time with My Mother" (Or any self-made title)

You should:

Spend quality time with your mother (or a mother figure in your life) during the holidays — it could be cooking together, going for a walk, talking about memories, doing a shared activity, or simply observing daily moments.

Document these moments using:

Video clips (recorded on phone or camera), Photos, Voice recordings or interviews, Background music or voiceover (optional)

Incorporate a connection to the poem by Kamala Das:

You can read a few lines from the poem as part of your video, or Add your own reflections on the themes of ageing, love, fear of separation, and realization of mortality.

What should be included?

- ✓ Clips or photos showing real moments with your mother.
- At least one personal reflection or voiceover where you express your thoughts (What do you notice? How do you feel? What have you realised?)
- ✓ A title screen and a closing screen with your name and class.

How to Submit:

Submit the documentary video on a pen drive/ via whatsApp in person, or email after the holidays.

Be ready to present a short 1–2-minute summary of your experience in class.

ACCOUNTANCY

Vishal Arora and Saurabh Das been working in hospitalisation and aviation industry for 5 years. Both intended to start their business. They decided to start a business of manufacturing, purchasing and selling furniture for home and office uses.

On 1st April 2016 they started their business under the name 'Comfort Furniture House' with a capital of ₹ 22, 50,000 Which was contributed equally by both the partners.

Sourabh hired an accountant and asked him to prepare a partnership bid for the firm, as per the terms and conditions agreed by both the partners.

Vishal opened a bank account in a Bank on 1st April, 2016 by depositing ₹15,00,000 in it. Information and transactions related to their business are given as follows:

- The partner took a premises on rent for setting their showroom. The monthly rent of the premises was ₹13,500. Rent for three months has been given on 1st April, 2016 in cash.
- O2 For establishing the showroom, he purchased the following items by cheque:-

a.	Refrigerator	₹22,500
b.	air conditioners,	₹72,000
c.	furniture and fixtures	₹37,500
d.	computers	₹54 000
e.	office equipment, including mobile phones,	₹40 500

They spent ₹24,000 on the interior decoration of the showroom by cheque for acquiring electricity connexion ₹7 500 was given as security deposit to BSES Yamuna Power Limited ₹3000 was given to reliance communication as security deposit for taking telephone connexion for the showroom for obtaining these connexions that is, electricity and phone. The payment is made by cheque.

They made people aware about their 'Comfort Furniture House' by holding and distributing pamphlets (advertisement expenses) which cost ₹4 500, and payment was made in cash.

All the Receipts were in caste to be deposited in the bank on the same day who stopped during the year. The business recorded a good turnover.

The partnership firm appointed 3 persons to help them in the showroom. The employee receives a salary of ₹10,500 per month during the year by cheque.

PROJECT

She purchased a building in her locality for setting up her gym, it cost rupees 4,00,000 fullest top. The payment was made through cash. Whole stop. She managed to get a loan of rupees 12 lakh for this purpose. The loan was repayable with interest of \P 2,40,000 in three yearly instalments. At the end of the first year, she had to repay \P 5,20,000 That is [\P 4,00,000 principal + \P 1,20,000. Interest].

Purchased exercising machines and equipment for ₹ 16 00 000 plus IGST at the rate of 18%. She gave ₹4 000 for electricity connection. In this tech-savy world to run a business successfully, she purchased computer worth ₹ 3,90,000 plus CGST and SGST at the rate of 9% each Paid a deposit of ₹10,000 with VSNL for Internet connection. She got her gym harnessed by paying ₹1,00,000 plus CGST and SGST at the rate of 14% each. She made people aware about her gym by distributing pamphlets, which cost her ₹18,000.

All payments were to be made by cheques. All the receipts were in cash to be deposited in the bank on the same day. The membership of the gym was available for ₹ 5000 for six weeks. At the end of the year, 31st March. 2025, the position of her business showed the following:
